GENERAL INFORMATION AND TEST RULES

- Entry Fee:** \$125 payable in US dollars. Entry fee includes a \$.50 AKC recording fee and \$3.00 event fee. Make checks payable to EDOC.
- Closing Date:** Entries will be accepted until 5:00 PM, Thursday November 29, 2018 after which time entries will not be accepted, canceled, altered or substituted.
- For other delivery options call test secretary for instructions. Make checks or money orders payable to EDOC. No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance.
- Drawing for Entries:** This test is limited to 5 dogs. A random drawing will take place Thursday, November 29, 2018, 5 PM, at the Emerald Dog Obedience Club training facility, 1000 Obie Street, Eugene, OR. Call or email the Test Secretary for directions to draw site. When the limit is reached, the drawing will continue and an alternate list will be established in the order in which entries are drawn.
- Eligibility for Entries:** Preference for entry is dogs who have not yet passed an AKC VST test.
- Test worker Option:** At the draw one (1) track will be allotted for test worker entry to be drawn before other entries. To be eligible for the Test Worker Draw, a Test Worker Certificate must be submitted with the entry. Test Worker entries not getting the track will be mixed into the remaining entries for drawing.
- Notification:** Acknowledgment of entries will be made as soon as possible after the drawing. If the exhibitor does not receive acknowledgment within a reasonable time please email greeneyeze@hotmail.com or call 760-220-8554.
- Draw for Running Order 10:00 AM:** Handlers must be at the Tracking Test area before 10:00 AM on Sunday, December 9, 2018, at which time there will be a drawing for track order. Entrants not present at the time of drawing for tracks may be marked absent and an alternate allowed to run in their place.
- Start of Judging:** Judging will start as soon as the first track has aged the required time. Test Hours: 8:00 am to 5:00 pm.
- Refund Policy:** The entry fee will be refunded if either 1) entrant notifies test secretary prior to the draw 1) the entrant notifies the secretary prior to the test and an alternate runs the track, or 2) the dog is an alternate who does not run a track.
- Bitches in Season:** Bitches in season may participate in this test. If your bitch is in season, when you arrive at the test site, park your vehicle well away from the other cars and notify the test secretary that your entered bitch is in season. The last track will be reserved for your bitch. If there is more than one bitch in season, a second draw for these bitches will be held. Bitches in season will be allowed to participate only after all other dogs and bitches not in season have been tested. Bitches in season must be kept away from the rest of the entered dogs. Failure to comply with these requirements will result in the handler and dog being excused from the test site and any award withheld.
- Directions to Test Site:** *Northbound from the south) on Interstate 5:* Exit 189 and at stop sign, turn left. At 2nd traffic light turn left on Eldon Shafer Dr. Turn right into first parking lot. *Southbound (from the north) on Interstate 5:* Exit 189 and continue to the traffic light. Turn right and go straight until the next traffic light. Turn right and get into left lane. Turn left on Eldon Shafer Dr and right into first parking lot.
- Extreme Weather Conditions:** The AKC believes the wellbeing of dogs and participants are of paramount importance. In the case of adverse weather conditions, the test could be canceled and rescheduled.
- Awards:** EDOC offers each passing dog a wooden plaque with a map of its track.
- AKC Rules:** All entrants are responsible for complying with the AKC rules regarding Tracking Tests and other AKC rules referred to in the Tracking Test Rule book.
- Post Test Lunch:** A no-host celebration will be held after the test. Location and directions will be available on test day. All are invited to attend.

PLEASE NOTE: There is no overnight parking or camping on campus. Do not arrive prior to 9:00 AM. Hotel information will be included with entry confirmation/judging program.
